

# Non small cell lung cancer metastatic cARBOplatin, PACLitaxel and pembrolizumab

## ⚠ ADDIKD Carboplatin dosing:

For dosing carboplatin, ADDIKD recommends that:

- Directly measured glomerular filtration rate (mGFR) is the preferred kidney function value in the Calvert formula, especially where estimated kidney function may be unreliable for accurate therapeutic dosing.
- Where mGFR is unavailable, eGFR adjusted to an individual's body surface area (BSA-adjusted eGFR) is a suitable alternative for use in the Calvert formula.
- Kidney function should not be capped at 125 mL/min for use in the Calvert formula.
- Recalculation of carboplatin doses at each cycle is unnecessary, except when baseline kidney function (e.g., eGFR) alters by > 20% or when there is a change in the clinical status of the patient.

Before commencing immunotherapy treatment in any patient, clinicians should have an understanding of the immune-related adverse events (irAEs) associated with immunotherapy treatment and their management.

## Treatment schedule - Overview

### Cycle 1 to 4

Drug	Dose	Route	Day
Pembrolizumab	200 mg	IV infusion	1
PACLitaxel	200 mg/m <sup>2</sup>	IV infusion	1
cARBOplatin	6 AUC *	IV infusion	1

### Cycle 5 to 35

It is the consensus of the eviQ Reference Committee that lower starting doses e.g. paclitaxel 175 mg/m<sup>2</sup> and carboplatin AUC 5 should be considered if clinically indicated.

\* If estimated GFR is >125 mL/min (i.e. 6 AUC dose >900 mg), obtaining direct measurement rather than an estimated renal function and/or dose capping is strongly recommended.

\*\* From cycle 5 onwards, pembrolizumab alternative dosing schedule of 400 mg every 42 days may be considered.<sup>1,2</sup>

**Frequency:** 21 days

**Cycles:** 35 or until disease progression or unacceptable toxicity (total maximum of 35 doses or 24 months treatment with pembrolizumab)

**Notes:**

In the first few months after the start of immunotherapy, some patients can have a transient tumour flare (termed 'pseudo progression' or an immune response). This may manifest as growth of existing lesions or the development of new lesions prior to later tumour regression. While this is rare, (~5%), continuing treatment and performing a second scan 4 to 6 weeks later to confirm progression may be considered, particularly if the patient is believed to be deriving clinical benefit.

Radiation recall has been observed with PD1 inhibitors, consideration should be given to the timing when starting this treatment after a prolonged course of radiation therapy.

**Frequency:** 21 days

**Cycles:** 35 or until disease progression or unacceptable toxicity (total maximum of 35 doses or 24 months treatment with pembrolizumab)

## Indications and patient population

### Indications:

- First line treatment of metastatic **squamous** non small cell lung cancer
- ECOG performance status 0 or 1

### Precautions:

If any of these conditions are present, clinical judgement should be used and individual cases discussed with an expert in the field as indicated:

- significant autoimmune disease (e.g. myasthenia gravis, inflammatory bowel disease, systemic lupus erythematosus, rheumatoid arthritis, autoimmune ocular disease)
- organ transplantation
- previous history of viral hepatitis
- HIV/acquired immune deficiency syndrome (AIDS)
- previous radiation to the lungs.

## Clinical information

<b>Venous access required</b>	IV cannula (IVC) or central venous access device (CVAD) is required to administer this treatment. Read more about <a href="#">central venous access device line selection</a>
<b>Hypersensitivity/infusion related reaction</b>	High risk with paclitaxel High risk with carboplatin. Hypersensitivity risk increases with number of cycles of carboplatin. Rechallenge with carboplatin after hypersensitivity carries a high risk of anaphylaxis, and where clinically indicated, should be undertaken with a desensitisation protocol with appropriate supports in place. <b>Premedication</b>	<p>The product information states that premedication is required for this treatment. Please refer to the treatment schedule for the suggested premedication regimen. This may be substituted to reflect institutional policy.</p> <p>Read more about <a href="#">premedication for prophylaxis of taxane hypersensitivity reactions</a></p>
<b>Emetogenicity MODERATE</b>	<p>Suggested default antiemetics have been added to the treatment schedule, and may be substituted to reflect institutional policy.</p> <p>Carboplatin AUC <math>\geq 4</math> is classified by MASCC/ESMO Antiemetic Guidelines 2016 and ASCO Antiemetic Guidelines 2017 as having moderate emetogenicity.</p> <p>However, a NK1 receptor antagonist and a 5HT<sub>3</sub> receptor antagonist in combination with dexamethasone are available on the PBS for primary prophylaxis of carboplatin induced nausea and vomiting.</p> <p>Note: a steroid has been included both as an antiemetic and premedication for hypersensitivity in this protocol.</p> <p>Ensure that patients also have sufficient antiemetics for breakthrough emesis:</p> <p>Metoclopramide 10 mg three times a day when necessary (maximum of 30 mg/24 hours, up to 5 days) OR</p> <p>Prochlorperazine 10 mg PO every 6 hours when necessary.</p> <p>Read more about <a href="#">preventing anti-cancer therapy induced nausea and vomiting</a></p>
<b>Immune-related adverse events (irAEs)</b>	<p>Immune-related adverse events (irAEs) can occur early and escalate quickly in patients receiving immune checkpoint inhibitors. irAEs can also occur after discontinuation of treatment. Fatalities have been reported. Management of irAEs is largely based on expert opinion and consensus guidelines.</p> <p>Examples of irAEs with high risk of mortality include:</p> <ul style="list-style-type: none"> <li>• cardiac toxicity: myocarditis</li> <li>• musculoskeletal toxicity: myositis</li> <li>• neurological toxicity: encephalitis, Guillain-Barré syndrome, myelitis, myasthenia gravis</li> <li>• pulmonary toxicity: pneumonitis</li> <li>• skin toxicity: Steven-Johnson syndrome, toxic epidermal necrolysis.</li> </ul> <p>Examples of irAEs in order of frequency include:</p> <ul style="list-style-type: none"> <li>• Common <ul style="list-style-type: none"> <li>◦ endocrinopathies: thyroid dysfunction</li> <li>◦ gastrointestinal toxicity: diarrhoea</li> <li>◦ musculoskeletal toxicity: arthralgia, myalgia</li> <li>◦ skin toxicity: rash, erythema, pruritus</li> </ul> </li> <li>• Less common <ul style="list-style-type: none"> <li>◦ endocrinopathies: hypophysitis, type I diabetes mellitus</li> <li>◦ gastrointestinal toxicity: colitis</li> <li>◦ musculoskeletal toxicity: inflammatory arthritis</li> <li>◦ ocular toxicity: dry eye</li> <li>◦ renal toxicity</li> <li>◦ skin toxicity: vitiligo</li> </ul> </li> <li>• Rare <ul style="list-style-type: none"> <li>◦ endocrinopathies: primary adrenal insufficiency</li> <li>◦ gastrointestinal toxicity: pancreatitis</li> <li>◦ haematological toxicity</li> <li>◦ musculoskeletal toxicity: vasculitis</li> <li>◦ ocular toxicity: uveitis, iritis.</li> </ul> </li> </ul> <p>Proactive monitoring, patient self-monitoring and early reporting of adverse events is critical. Treatment interruptions/discontinuation, consultation with specialist and administration of corticosteroids and/or supportive care is required to minimise the risk of death.</p> <p>Read more about the <a href="#">management of immune-related adverse events (irAEs)</a></p>

<b>Peripheral neuropathy</b>	<p>Assess prior to each treatment. If a patient experiences grade 2 or greater peripheral neuropathy, a dose reduction, delay, or omission of treatment may be required; review by medical officer before commencing treatment.</p> <p>Read more about <a href="#">peripheral neuropathy</a></p> <p>Link to <a href="#">chemotherapy-induced peripheral neuropathy screening tool</a></p>
<b>Baseline investigations</b>	<p>Consider ECG and troponin at baseline. There is no clear evidence regarding the efficacy/value of baseline ECG or troponin in patients receiving immune checkpoint inhibitor therapy. Some cancer specialists obtain baseline testing, and others continue this through the initial period of therapy. Consider urinalysis at baseline, particularly in patients with additional risk factors for developing immune-related acute kidney injury.</p>
<b>Blood tests</b>	<p>FBC, EUC, eGFR, LFTs, calcium, magnesium, serum cortisol, TFTs and BSL at baseline.</p> <p>Repeat FBC, EUC, eGFR, LFTs and BSL prior to each cycle and serum cortisol and TFTs alternate cycles. Calcium and magnesium as clinically indicated. Check lipase and amylase if symptomatic of pancreatitis.</p> <p>Recalculation of carboplatin doses at each cycle is unnecessary, except when baseline kidney function (e.g., eGFR) alters by greater than 20% or when there is a change in the clinical status of the patient.</p> <p>In the absence of suspicion of immune related adverse events less frequent monitoring may be applicable, according to institutional guidelines. Evidence for the frequency of routine blood testing with immunotherapies varies within published studies and guidelines.</p> <p>Read more about <a href="#">immunotherapy blood test monitoring recommendations</a></p>
<b>Hepatitis and HIV</b>	<p>Hepatitis screening is recommended in all patients who are to receive immune checkpoint inhibitors.</p> <p>Immunotherapy is associated with inflammatory adverse reactions resulting from increased or excessive immune activity and patients are at risk of developing autoimmune hepatitis. It should be used with caution in patients who have a history of chronic hepatic infections (hepatitis B and C), detectable human immunodeficiency virus (HIV) viral load or acquired immune deficiency syndrome (AIDS).</p>
<b>Vaccinations</b>	<p>Live vaccines are contraindicated in cancer patients receiving immunosuppressive therapy and/or who have poorly controlled malignant disease.</p> <p>The safety of having vaccinations during immunotherapy is unknown. Patients in the clinical trials were typically allowed to receive inactivated and recombinant vaccines but not live vaccines.</p> <p>Refer to the recommended schedule of vaccination for immunocompromised patients, as outlined in the <a href="#">Australian Immunisation Handbook</a>.</p> <p>Read more about <a href="#">COVID-19 vaccines and cancer</a>.</p>
<b>Effects of cancer treatment on fertility</b>	<p>Cancer treatment can have harmful effects on fertility and this should be discussed with all patients of reproductive potential prior to commencing treatment.</p> <p>Studies to evaluate the effects of immune checkpoint inhibitor therapy on fertility have not been performed. Therefore, the effect on male and female fertility is unknown. Limited evidence supports that immune checkpoint inhibitor-related hypogonadism due to orchitis and hypophysitis can impact fertility. Immune checkpoint inhibitors can cause fetal harm when given to pregnant women. A pregnancy test should be considered in females of reproductive potential if sexually active. It is important that all patients of reproductive potential use effective contraception whilst on therapy and after treatment finishes. There is very limited evidence to provide guidance regarding contraception timelines. Some studies have demonstrated PD-1 receptor occupancy for greater than 9 months after anti-PD-1 therapy (Brahmer et al., 2010). As a result, some cancer specialists advise using contraception for at least six months or even as long as two years after treatment finishes.</p> <p>Read more about the <a href="#">effect of cancer treatment on fertility</a></p> <p>Link to <a href="#">Brahmer et al., 2010</a></p>

## Dose modifications

Evidence for dose modifications is limited, and the recommendations made on eviQ are intended as a guide only. They are generally conservative with an emphasis on safety. Any dose modification should be based on clinical judgement, and the individual patient's situation including but not limited to treatment intent (curative vs palliative), the anti-cancer regimen (single versus combination therapy versus chemotherapy versus immunotherapy), biology of the cancer (site, size, mutations, metastases), other treatment related side effects, additional co-morbidities, performance status and patient preferences. Suggested dose modifications are based on clinical trial findings, product information, published guidelines and reference committee consensus. The dose reduction applies to each individual dose and not to the total number of days or duration of treatment cycle unless stated otherwise. Non-haematological gradings are based on [Common Terminology Criteria for Adverse Events \(CTCAE\)](#) unless otherwise specified. Renal and hepatic dose modifications have been standardised where possible. For more information see dosing considerations & disclaimer.

The dose recommendations in kidney dysfunction (i.e. renal impairment) displayed may not reflect those in the ADDIKD guideline and have been included for historical reference only. Recommendations will be updated once the individual protocol has been evaluated by the reference committee, with this version of the protocol then being archived. Clinicians are expected to refer to the ADDIKD guideline prior to prescribing in kidney dysfunction.

**Immune checkpoint inhibitor dose modifications**

- Dose reduction is not recommended
- No dose adjustment is required in the elderly, mild or moderate renal impairment or mild hepatic impairment. Immune checkpoint inhibitors have not been studied in patients with severe renal impairment or moderate to severe hepatic impairment.

ANC x 10 <sup>9</sup> /L (pre-treatment blood test)	
1.0 to less than 1.5	Refer to local institutional guidelines; it is the view of the expert clinicians that treatment should continue if patient is clinically well.
0.5 to less than 1.0	Delay treatment until recovery
less than 0.5	Delay treatment until recovery and reduce paclitaxel and carboplatin by 25% for subsequent cycles
Febrile neutropenia	Delay treatment until recovery and reduce paclitaxel and carboplatin by 25% for subsequent cycles

Grade 3 or Grade 4	Delay treatment until toxicity has resolved to Grade 1 or less and reduce doses for subsequent cycles as follows: 1 <sup>st</sup> occurrence: Reduce paclitaxel and carboplatin by 50% 2 <sup>nd</sup> occurrence: Omit paclitaxel and carboplatin

<b>Ototoxic drugs (e.g. aminoglycosides, frusemide, NSAIDs)</b>	Additive ototoxicity	Avoid combination or perform regular audiometric testing
<b>Paclitaxel</b>	Administration schedule may influence the development of myelosuppression	Minimise toxicity by administering paclitaxel first in regimens using the combination

<b>CYP3A4 inhibitors (e.g. aprepitant, azole antifungals, clarithromycin, erythromycin, grapefruit juice, ritonavir etc.)</b>	Increased toxicity of paclitaxel possible due to reduced clearance	Monitor for paclitaxel toxicity
<b>CYP3A4 inducers (e.g. carbamazepine, phenytoin, phenobarbitone, rifampicin, St John's wort etc.)</b>	Reduced efficacy of paclitaxel possible due to increased clearance	Monitor for decreased clinical response to paclitaxel
<b>CYP2C8 inhibitors (e.g. pazopanib, lapatinib, gemfibrozil, montelukast etc.)</b>	Increased toxicity of paclitaxel possible due to reduced clearance	Monitor for paclitaxel toxicity
<b>Metronidazole, disulfiram</b>	Intolerance reaction to alcohol content of diluent of intravenous paclitaxel	Avoid combination
<b>Doxorubicin</b>	Administration schedule can influence systemic exposure to doxorubicin	Minimise by administering doxorubicin first in regimens using the combination

## Pembrolizumab

No formal pharmacokinetic drug interaction studies have been conducted with pembrolizumab. Since pembrolizumab is cleared from the circulation through catabolism, no metabolic drug-drug interactions are expected.

	Interaction	Clinical management
<b>Immunosuppressants (inc. corticosteroids)</b>	Reduced efficacy of both immunosuppressants and pembrolizumab possible due to pharmacodynamic interaction	It is recommended that patients requiring corticosteroids <b>prior</b> to treatment receive the lowest possible dose (preferably no greater than 10 mg prednisolone or equivalent steroid per day). <b>Once started</b> on pembrolizumab the use of corticosteroids to treat immune related adverse events (irAEs) does not appear to impact the clinical response to pembrolizumab. In patients requiring ongoing corticosteroids <b>post management</b> of an irAE, the dose should be as low as possible.  Monitor for signs of organ rejection in transplant recipients.
<b>Nephrotoxic drugs (e.g. aminoglycosides, amphotericin, contrast dye, frusemide, NSAIDs)</b>	Additive nephrotoxicity	Avoid combination or monitor kidney function closely

NK-1 antagonist e.g. aprepitant, fosaprepitant, netupitant		
	Interaction	Clinical management
<b>Dexamethasone</b>	Increased effects/toxicity of dexamethasone due to inhibition of its metabolism via CYP3A4	Reduce dose of <b>antiemetic dexamethasone</b> by approximately 50% when adding a NK-1 antagonist. For protocols that already recommend a NK-1 antagonist, the dose reduction of <b>antiemetic dexamethasone</b> has already been taken into account.  If <b>dexamethasone is part of the chemotherapy protocol</b> , dose reduction as per the product information is not routinely recommended in clinical practice and no additional dexamethasone is required for antiemetic cover.
<b>Warfarin</b>	Reduced anticoagulant efficacy of warfarin due to increased clearance (aprepitant induces CYP2C9). *Note interaction only applicable to aprepitant/ fosaprepitant	INR should be monitored in the 2 week period, particularly at 7 to 10 days following the administration of aprepitant/ fosaprepitant
<b>Combined oral contraceptive</b>	Reduced contraceptive efficacy due to increased clearance. *Note interaction only applicable to aprepitant/ fosaprepitant	Alternative non-hormonal methods should be used during and for 1 month after stopping aprepitant/ fosaprepitant

## Evidence

The evidence supporting this protocol is provided by a phase 3 multicentre international randomised trial (KEYNOTE-407) involving 559 patients comparing pembrolizumab or placebo in combination with carboplatin plus either paclitaxel or nab-paclitaxel in patients with previously untreated stage 4 squamous non-small cell lung cancer.<sup>3</sup>

Between August 2016 and December 2017, 278 patients were randomised to receive 4 cycles of carboplatin (AUC 6 every 3 weeks) plus either paclitaxel (200 mg/m<sup>2</sup> every 3 weeks) or nab-paclitaxel (100 mg/m<sup>2</sup> weekly) plus pembrolizumab (200 mg every 3 weeks). 281 patients were randomised to receive 4 cycles of carboplatin (AUC 6 every 3 weeks) plus either paclitaxel (200 mg/m<sup>2</sup> every 3 weeks) or nab-paclitaxel (100 mg/m<sup>2</sup> weekly) plus placebo (every 3 weeks). Pembrolizumab or placebo was continued every 3 weeks for up to a total of 35 cycles.

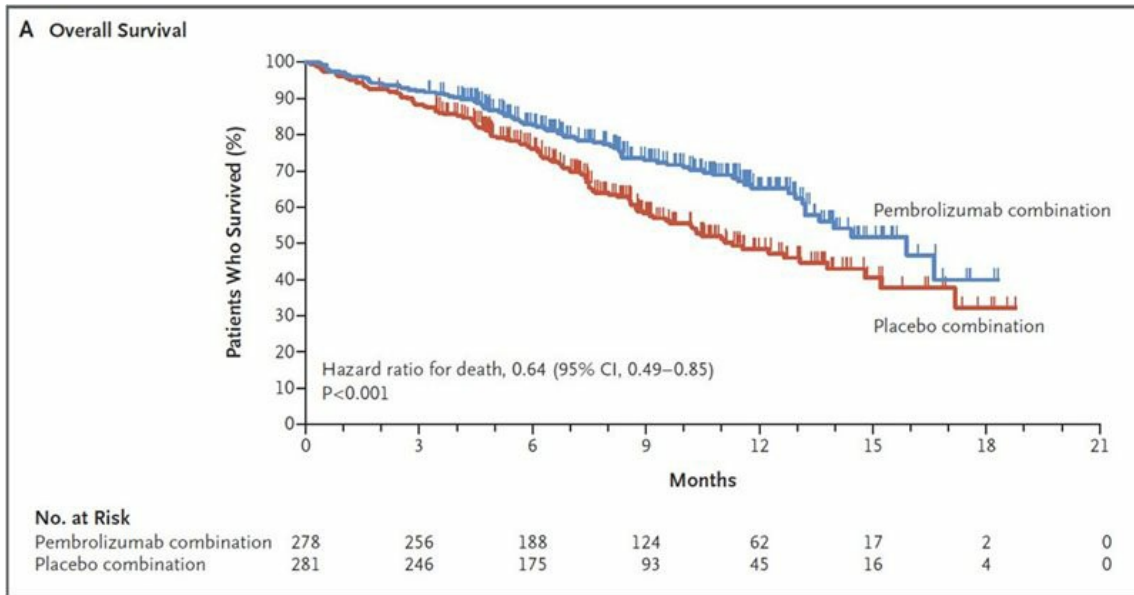
The primary end points were progression free survival and overall survival. Secondary end points were objective response rate and duration of response rate.



## Efficacy

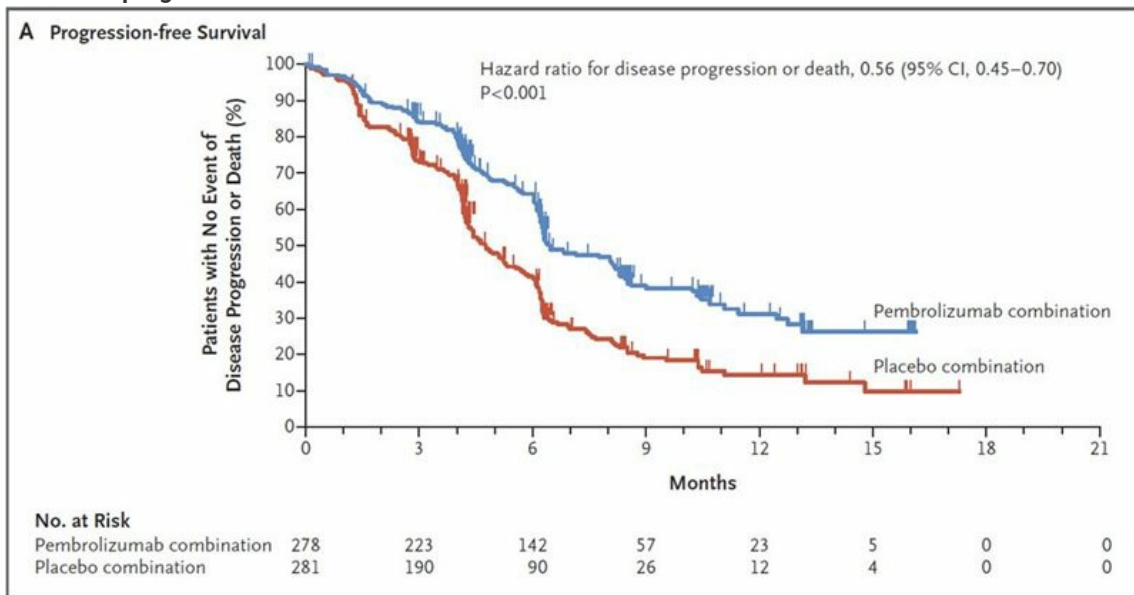
After a median follow up of 7.8 months, the median overall survival was 15.9 months in the pembrolizumab combination group vs 11.3 months in the placebo combination group (HR 0.64; 95% CI, 0.49-0.85;  $p < 0.001$ ). The median progression free survival was 6.4 months in the pembrolizumab combination group compared to 4.8 months in the placebo combination group (HR 0.56; 95% CI, 0.45-0.70).

All subgroups, including PD-L1 tumour proportion score  $< 1\%$ , showed benefit in both overall survival and progression-free survival with the addition of pembrolizumab.

## Toxicity

Grade 3 or higher adverse events occurred in 69.8% of patients in the pembrolizumab combination group compared with 68.2% in the placebo combination group. Discontinuation of all treatment drugs due to adverse events was more frequent in the pembrolizumab combination group than in the placebo combination group (13.3% vs 6.4%).

# Patient information - Lung cancer metastatic - Carboplatin, paclitaxel and pembrolizumab

Patient's name:

## Your treatment

It is important to understand that pembrolizumab is not a traditional chemotherapy drug and has a different way of working. It is an immunotherapy treatment (also called anticancer drug) that works with your immune system to detect and destroy cancer cells.

The treatment schedule below explains how the drugs for this treatment are given.

### Carboplatin, paclitaxel and pembrolizumab cycles 1 to 4

This treatment cycle is repeated every 21 days. You will have 4 treatments with carboplatin, paclitaxel and pembrolizumab followed by up to 31 cycles of pembrolizumab (total of 35 cycles or 2 years of treatment).

### Pembrolizumab cycles 5 to 35


This treatment cycle is repeated every 21 days. You will have up to 31 cycles of this treatment after completing 4 cycles of carboplatin, paclitaxel and pembrolizumab (total of 35 cycles or 2 years of treatment). Your doctor advise you of the number of treatments you will have.

**Prior to your treatment** tell your doctor if you are taking any other medicines (e.g. corticosteroids, immunosuppressive therapy), have or ever had chronic liver infections e.g. hepatitis B (HBV) or C (HCV), human immunodeficiency virus (HIV) or an organ transplant.

## When to get help

Anticancer drugs (drugs used to treat cancer) can sometimes cause serious problems. It is important to get medical help immediately if you become unwell.

 <p><b>IMMEDIATELY go to your nearest hospital Emergency Department, or contact your doctor or nurse if you have any of the following at any time:</b></p>	<b>Emergency contact details</b> Ask your doctor or nurse from your treating team who to contact if you have a problem

- you become unwell.

**It is important that you tell your doctor or nurse immediately if you develop any of the immune related side effects listed below. If you can't contact your doctor or nurse, go to your nearest hospital Emergency Department.**

**During your treatment immediately** tell the doctor or nurse looking after you if you get any of the following problems:

- leaking from the area where the drugs are being given
- pain, stinging, swelling or redness in the area where the drugs are being given or at any injection sites
- a skin rash, itching, feeling short of breath, wheezing, fever, shivers, or feeling dizzy or unwell in any way (allergic reaction).

## Other information about your treatment

### Changes to your dose or treatment delays

Sometimes a treatment may be started at a lower dose or the dose needs to be changed during treatment. There may also be times when your treatment is delayed. This can happen if your doctor thinks you are likely to have severe side effects, if you get severe side effects, if your blood counts are affected and causing delays in treatment, or if you are finding it hard to cope with the treatment. This is called a dose reduction, dose change or treatment delay. Your doctor will explain if you need any changes or delays to your treatment and the reason why.

### Blood tests and monitoring

Anti-cancer drugs can reduce the number of blood cells in your body. You will need to have regular blood tests to check that your blood cell count has returned to normal. If your blood count is low, your treatment may be delayed until it has returned to normal. Your doctor or nurse will tell you when to have these blood tests.

### Other medications given during this treatment

- **Anti-sickness (anti-nausea) medication:** you may be given some anti-sickness medication. Make sure you take this medication as your doctor or nurse tells you, even if you don't feel sick. This can help to prevent the sickness starting.
- **Paclitaxel premedication:** before your treatment with paclitaxel you may need to take some tablets called a premedication to help prevent you from having a reaction to the paclitaxel. The following table may be used to remind you when to take your premedication. Ask your doctor, nurse or pharmacist to fill it out for you.

Tablet	Dose	When to take

Tell your doctor or nurse if you have not taken your premedications before you have your treatment.

- **Steroids:** you may be given some steroid tablets to help reduce immune-related side effects. Your doctor or nurse will tell you how and when to take the steroids. You may need to monitor your blood sugar levels closely while you are taking steroids. If you have diabetes, your diabetic medication may need to be adjusted because of the effects of steroids. Speak to your diabetes advisor.

## Side effects

Cancer treatments can cause damage to normal cells in your body, which can cause side effects. Everyone gets different side effects, and some people will have more problems than others.

The table below shows some of the side effects you may get with this treatment. You are unlikely to get all of those listed and you may also get some side effects that have not been listed.

Tell your doctor or nurse about any side effects that worry you. Follow the instructions below and those given to you by your doctor



or nurse.

Immunotherapy may cause serious immune reactions against your own body. These are called immune-related adverse events. They may occur during your treatment, or after your treatment has ended. Immunotherapy can affect many parts of your body. Some side effects can cause severe or life threatening conditions, so even mild side effects must be reported immediately. Do not try to treat these symptoms yourself without talking to your doctor or nurse first. You will be given an information pack at the start of your treatment. This contains an alert card which you should carry with you at all times. Bring this alert card with you to hospital, especially if you are unwell or attending the emergency department.

This treatment uses both chemotherapy and immunotherapy. These drugs work in different ways, but can cause similar side effects.

Immune related side effects	
<b>Heart problems</b>	<ul style="list-style-type: none"><li>• You may get:<ul style="list-style-type: none"><li>◦ chest pain or tightness</li><li>◦ shortness of breath</li><li>◦ swelling of your ankles</li><li>◦ an abnormal heartbeat.</li></ul></li><li>• Heart problems are uncommon but potentially fatal. If heart problems were to occur, symptoms usually start within the first 3 months of treatment, but can happen at any time even after the treatment has finished.</li><li>• Tell your doctor if you have a history of heart problems or high blood pressure.</li><li>• Before or during treatment, you may be asked to have a test to see how well your heart is working.</li><li>• <b>Tell your doctor or nurse immediately, or go to the nearest hospital Emergency Department if you get any of the symptoms listed above.</b></li></ul>
<b>Bowel and stomach inflammation</b>	<ul style="list-style-type: none"><li>• You may get:<ul style="list-style-type: none"><li>◦ bowel motions (stools, poo) that are more frequent or more liquid (diarrhoea)</li><li>◦ blood or mucous in your stool</li><li>◦ dark, tarry, or sticky bowel motions</li><li>◦ bloating, cramping, pain or tenderness in your stomach area.</li></ul></li><li>• Inform your doctor or nurse immediately if you get diarrhoea</li><li>• Take your anti-diarrhoeal or steroid medication as directed by your doctor.</li><li>• Drink plenty of fluids (unless you are on a fluid restriction).</li><li>• Eat and drink small amounts more often.</li><li>• Avoid spicy foods, dairy products, high fibre foods, and coffee.</li><li>• <b>Tell your doctor or nurse immediately, or go to your nearest hospital Emergency Department if your diarrhoea is not controlled despite taking anti-diarrhoea medicine, severe stomach pains and bloating, and/or if you feel dizzy or light-headed.</b></li></ul>
<b>Blood problems</b>	<ul style="list-style-type: none"><li>• Blood problems are infrequent but can be serious.</li><li>• You may feel dizzy, light-headed, tired, weak and appear more pale than usual.</li><li>• You may get:<ul style="list-style-type: none"><li>• dark, tarry bowel motions (stools, poo)</li><li>• blood in your urine or not urinating as often</li><li>• dark-coloured urine</li><li>• yellowing of the whites of your eyes, and/or your skin</li><li>• pinpoint red spots on your skin</li><li>• unexplained bleeding</li><li>• major bruising</li><li>• a fever</li><li>• shortness of breath</li><li>• a severe headache</li><li>• confusion</li><li>• faster heartbeat than normal</li></ul></li><li>• <b>Tell your doctor or nurse immediately or go to the nearest hospital Emergency Department if it has been longer than 12 hours since you have emptied your bladder or if you get any of the symptoms listed above.</b></li></ul>

<b>Kidney damage</b>	<ul style="list-style-type: none"> <li>• This treatment can cause changes to how your kidneys work.</li> <li>• You may get: <ul style="list-style-type: none"> <li>◦ a feeling of needing to urinate less often than normal</li> <li>◦ blood in your urine</li> <li>◦ swollen hands and feet</li> <li>◦ loss of appetite.</li> </ul> </li> <li>• You will have regular blood tests to check how well your kidneys are working.</li> <li>• You may need to drink more fluids while you are having treatment. Your doctor or nurse will tell you if you need to do this.</li> <li>• Take your steroid medication as directed by your doctor.</li> <li>• <b>Tell your doctor or nurse as soon as possible if you notice that your urine changes colour or you don't need to empty your bladder as often.</b></li> </ul>

<p><b>Skin rash</b></p>	<ul style="list-style-type: none"> <li>• You may get <ul style="list-style-type: none"> <li>◦ a red rash</li> <li>◦ a bumpy rash</li> <li>◦ dry and itchy skin</li> <li>◦ skin peeling or blisters.</li> <li>◦ if you have had previous radiation therapy to an area this effect may be worse</li> </ul> </li> <li>• Moisturise your skin with a gentle non-perfumed moisturising cream like sorbolene or aqueous cream.</li> <li>• Avoid scratching your skin.</li> <li>• Avoid wearing tight fitting clothing</li> <li>• Protect your skin from the sun by wearing sun-protective clothing, a wide-brimmed hat, sunglasses and sunscreen of SPF 50 or higher.</li> <li>• Take your antihistamine medication or apply your steroid cream as directed by your doctor.</li> <li>• <b>Tell your doctor or nurse as soon as possible if you notice any changes to the rash like pain or pus forming.</b></li> </ul>
<p><b>Thyroid problems</b></p>	<p>Thyroid problems are common with this treatment. The most common problem is an underactive thyroid gland (hypothyroidism), occasionally you may get an overactive thyroid gland (hyperthyroidism).</p> <ul style="list-style-type: none"> <li>• If you have an <b>underactive</b> thyroid, you may get: <ul style="list-style-type: none"> <li>◦ fatigue and low energy levels</li> <li>◦ depression</li> <li>◦ slow heart rate</li> <li>◦ unexplained weight gain</li> <li>◦ intolerance to cold temperatures</li> <li>◦ fatigued and aching muscles</li> <li>◦ dry, coarse skin</li> <li>◦ puffy face</li> <li>◦ hair loss</li> <li>◦ constipation</li> <li>◦ problems with concentration</li> <li>◦ changes in your periods</li> </ul> </li> <li>• If you have an <b>overactive</b> thyroid, you may get <ul style="list-style-type: none"> <li>◦ abnormal heartbeat (faster than usual)</li> <li>◦ a feeling of being hot or cold more easily</li> <li>◦ excessive sweating</li> <li>◦ difficulty sleeping</li> <li>◦ anxiety, nervousness or agitated more easily</li> <li>◦ diarrhoea</li> <li>◦ changes in your periods</li> </ul> </li> <li>• You will have regular blood tests to check how well your thyroid is working.</li> <li>• Take your hormone or steroid medication as directed by your doctor.</li> <li>• Tell your doctor or nurse if you get any of the symptoms listed above.</li> </ul>

## Chemotherapy immediate (onset hours to days)

<b>Allergic reaction</b>	<ul style="list-style-type: none"><li>• Allergic reactions are uncommon but can be life threatening.</li><li>• <b>If you feel unwell during the infusion or shortly after it, or:</b><ul style="list-style-type: none"><li>◦ <b>get a fever, shivers or shakes</b></li><li>◦ <b>feel dizzy, faint, confused or anxious</b></li><li>◦ <b>start wheezing or have difficulty breathing</b></li><li>◦ <b>have a rash, itch or redness of the face</b></li></ul></li></ul> <p><b><u>While you are in hospital:</u> Tell your doctor or nurse immediately.</b></p> <p><b><u>After you leave:</u> Contact your doctor or nurse immediately, or go to the nearest hospital Emergency Department.</b></p>
<b>Nausea and vomiting</b>	<ul style="list-style-type: none"><li>• You may feel sick (nausea) or be sick (vomit).</li><li>• Take your anti-sickness medication as directed even if you don't feel sick.</li><li>• Drink plenty of fluids (unless you are fluid restricted).</li><li>• Eat small meals more frequently.</li><li>• Try food that does not require much preparation.</li><li>• Try bland foods like dry biscuits or toast.</li><li>• Gentle exercise may help with nausea.</li><li>• Ask your doctor or nurse for eviQ patient information - <a href="#">Nausea and vomiting during cancer treatment</a>.</li><li>• <b>Tell your doctor or nurse immediately, or go to the nearest hospital Emergency Department if you have uncontrolled vomiting or feel dizzy or light-headed.</b></li></ul>

## Chemotherapy early (onset days to weeks)

<b>Infection risk (neutropenia)</b>	<ul style="list-style-type: none"><li>• This treatment lowers the amount of white blood cells in your body. The type of white blood cells that help to fight infection are called neutrophils. Having low level of neutrophils is called neutropenia. If you have neutropenia, you are at greater risk of getting an infection. It also means that your body can't fight infections as well as usual. This is a serious side effect, and can be life threatening.</li><li>• Wash your hands often.</li><li>• Keep a thermometer at home and take your temperature regularly, and if you feel unwell.</li><li>• Do your mouth care regularly.</li><li>• Inspect your central line site (if you have one) daily for any redness, pus or swelling.</li><li>• Limit contact with people who are sick.</li><li>• Learn how to recognise the signs of infection.</li><li>• Ask your doctor or nurse for eviQ patient information - <a href="#">Infection during cancer treatment</a>.</li><li>• <b>Tell your doctor or nurse immediately, or go to the nearest hospital Emergency Department if you get any of the following signs or symptoms:</b><ul style="list-style-type: none"><li>◦ <b>a temperature of 38°C or higher</b></li><li>◦ <b>chills, shivers, sweats or shakes</b></li><li>◦ <b>a sore throat or cough</b></li><li>◦ <b>uncontrolled diarrhoea</b></li><li>◦ <b>shortness of breath</b></li><li>◦ <b>a fast heartbeat</b></li><li>◦ <b>become unwell even without a temperature.</b></li></ul></li></ul>

<p><b>Low platelets (thrombocytopenia)</b></p>	<ul style="list-style-type: none"> <li>• This treatment lowers the amount of platelets in your blood. Platelets help your blood to clot. When they are low, you are at an increased risk of bleeding and bruising.</li> <li>• Try not to bruise or cut yourself.</li> <li>• Avoid contact sport or vigorous exercise.</li> <li>• Clear your nose by blowing gently.</li> <li>• Avoid constipation.</li> <li>• Brush your teeth with a soft toothbrush.</li> <li>• Don't take aspirin, ibuprofen or other similar anti-inflammatory medications unless your doctor tells you to.</li> <li>• Tell your doctor or nurse if you have any bruising or bleeding.</li> <li>• <b>Tell your doctor or nurse immediately, or go to your nearest hospital Emergency Department if you have any uncontrolled bleeding.</b></li> </ul>
<p><b>Mouth pain and soreness (mucositis)</b></p>	<ul style="list-style-type: none"> <li>• You may have: <ul style="list-style-type: none"> <li>◦ bleeding gums</li> <li>◦ mouth ulcers</li> <li>◦ a white coating on your tongue</li> <li>◦ pain in the mouth or throat</li> <li>◦ difficulty eating or swallowing.</li> </ul> </li> <li>• Avoid spicy, acidic or crunchy foods and very hot or cold food and drinks.</li> <li>• Try bland and soft foods.</li> <li>• Brush your teeth gently with a soft toothbrush after each meal and at bedtime. If you normally floss continue to do so.</li> <li>• Rinse your mouth after you eat and brush your teeth, using either: <ul style="list-style-type: none"> <li>◦ 1/4 teaspoon of salt in 1 cup of warm water, or</li> <li>◦ 1/4 teaspoon of bicarbonate of soda in 1 cup of warm water</li> </ul> </li> <li>• Ask your doctor or nurse for eviQ patient information - <a href="#">Mouth problems during cancer treatment</a>.</li> <li>• <b>Tell your doctor or nurse if you get any of the symptoms listed above.</b></li> </ul>
<p><b>Tiredness and lack of energy (fatigue)</b></p>	<ul style="list-style-type: none"> <li>• You may feel very tired, have no energy, sleep a lot, and not be able to do normal activities or things you enjoy.</li> <li>• Do not drive or operate machinery if you are feeling tired.</li> <li>• Nap for short periods (only 1 hour at a time)</li> <li>• Prioritise your tasks to ensure the best use of your energy.</li> <li>• Eat a well balanced diet and drink plenty of fluids (unless you are fluid restricted).</li> <li>• Try some gentle exercise daily.</li> <li>• Allow your friends and family to help.</li> <li>• <b>Tell your doctor or nurse if you get any of the symptoms listed above.</b></li> </ul>
<p><b>Nerve damage (peripheral neuropathy)</b></p>	<ul style="list-style-type: none"> <li>• You may notice a change in the sensations in your hands and feet, including: <ul style="list-style-type: none"> <li>◦ tingling or pins and needles</li> <li>◦ numbness or loss of feeling</li> <li>◦ pain.</li> </ul> </li> <li>• You may find it difficult to do everyday activities, such as doing up buttons or picking up small objects.</li> <li>• Test water temperature with your elbow when bathing to avoid burns.</li> <li>• Use rubber gloves, pot holders and oven mitts in the kitchen.</li> <li>• Wear rubber shoes or boots when working in the garden or garage.</li> <li>• Keep rooms well lit and uncluttered.</li> <li>• Ask your doctor or nurse for eviQ patient information – <a href="#">Nerve problems during cancer treatment</a>.</li> <li>• Tell your doctor or nurse if you get any of the symptoms listed above.</li> </ul>

## Chemotherapy late (onset weeks to months)

<b>Low red blood cells (anaemia)</b>	<ul style="list-style-type: none"><li>• You may feel dizzy, light-headed, tired and appear more pale than usual.</li><li>• Tell your doctor or nurse if you have any of these signs or symptoms. You might need a blood transfusion.</li><li>• <b>Tell your doctor or nurse immediately, or go to the nearest hospital Emergency Department if you have any chest pain, trouble breathing, or feel like your heart is racing.</b></li></ul>
<b>Hair loss (alopecia)</b>	<ul style="list-style-type: none"><li>• Your hair may start to fall out from your head and body.</li><li>• Hair loss usually starts 2 to 3 weeks after your first treatment.</li><li>• You may become completely bald and your scalp might feel tender.</li><li>• Use a gentle shampoo and a soft brush.</li><li>• Take care with hair products like hairspray, hair dye, bleaches and perms.</li><li>• Protect your scalp from the cold with a hat, scarf or wig.</li><li>• Protect your scalp from the sun with a hat or sunscreen of SPF 50 or higher.</li><li>• Moisturise your scalp to prevent itching.</li><li>• Ask your doctor or nurse about the <a href="#">Look Good Feel Better</a> program</li></ul>
<b>Nail changes</b>	<ul style="list-style-type: none"><li>• Your nails may:<ul style="list-style-type: none"><li>◦ grow more slowly</li><li>◦ become darker</li><li>◦ develop ridges or white lines</li><li>◦ become brittle and flaky</li></ul></li><li>• In some cases, you may lose your nails completely.</li><li>• Keep your nails clean and short.</li><li>• Avoid things like biting your fingernails, getting a manicure, pedicure or false nails.</li><li>• Wear gloves when you wash the dishes, work in the garden, or clean the house.</li></ul>

## General advice for patients having cancer treatment

### Chemotherapy safety

- Learn how to keep you and your family safe while you are having anticancer drugs.

### Blood clot risk

- Cancer and anticancer drugs can increase the risk of a blood clot (thrombosis).
- Tell your doctor if you have a family history of blood clots.
- A blood clot can cause pain, redness, swelling in your arms or legs, shortness of breath or chest pain.
- If you have any of these symptoms go to your nearest hospital Emergency Department.

### Medications and vaccinations

- Before you start treatment, tell your doctor about any medications you are taking, including vitamins or herbal treatments.
- Don't stop or start any medications during treatment without talking to your doctor and pharmacist first.
- Paracetamol is safe to take if you have a headache or other mild aches and pains. It is recommended that you avoid taking aspirin, ibuprofen and other anti-inflammatory type medications for pain while you are having treatment. However, if these medications have been prescribed by your doctor, do not stop taking them without speaking with your doctor.
- Don't have **any** vaccinations without talking to the doctor who is managing your cancer treatment.
- People you live with should be fully vaccinated, according to the current vaccination schedule. Extra care needs to be taken with hand washing and careful disposal of soiled nappies for infants who have recently received the rotavirus vaccine.

### Other medical and dental treatment

- If you go to hospital or any other medical appointment (including dental appointments), always tell the person treating you that you are receiving anticancer drugs.
- Before you have any dental treatment, talk to your doctor.

### Diet

- While you are receiving this treatment it is important that you try to maintain a healthy diet.
- Grapefruit and grapefruit juice can interact with your medication and should be avoided while you are on this treatment.
- Speak to your doctor or nurse about whether drinking alcohol is safe with your treatment.
- If you have any concerns about recent weight loss or weight gain or questions about your diet, ask to speak to a dietitian.

### Fertility

- Some cancer treatments can reduce your fertility. This can make it difficult or impossible to get pregnant or father a child.
- Talk to your doctor or nurse before you start any treatment. Depending on your situation there may be fertility sparing options available to you and/or your partner, discuss these with your doctor or nurse.

### Pregnancy and breastfeeding

- Some cancer treatments can be dangerous to unborn babies. Talk to your doctor or nurse if you think there is any chance that you could be pregnant.
- Do not try to get pregnant or father a child during this treatment. Contraception should be used during treatment and after stopping treatment. Ask your doctor or nurse about what type of contraception you should use.
- If you are planning pregnancy/fatherhood after completing this treatment, talk to your doctor. Some doctors advise waiting between 6 months and 2 years after treatment.
- Do not breastfeed if you are on this treatment, as anti-cancer medications can also pass into breast milk.

### Sex life and sexuality

- The desire to have sex may decrease as a result of this treatment or its side effects.
- Your emotions and the way you feel about yourself may also be affected by this treatment.
- It may help to discuss your concerns with your partner and doctor or nurse.

### Quitting smoking

- It is never too late to quit smoking. Quitting smoking is one of the best things you can do to help your treatment work better.
- There are many effective tools to improve your chances of quitting.
- Talk to your treating team for more information and referral to a smoking cessation support service.

### Staying active

- Research shows that exercise, no matter how small, has many benefits for people during and after cancer treatment.
- Talk to your doctor before starting an exercise program. Your doctor can advise whether you need a modified exercise program.
